How much concentrate pipe can I put between the bladder tank and the proportioner?

In general, you can allow up to 35 feet of equivalent-length pipe at the same diameter as the line entering the ratio controller.

What application rates do I need?

Check the UL product iQ® or the FM Approval Guide for application rates because they vary based on the product.

Is new hardware required for fluorine-free foam?

The same style of hardware can be used, but any change in foam concentrate will potentially require a change in the components. This has been the “best practice” and is not new to fluorine-free foam.
